THIS PROGRAM IS SUPPORTED BY GOVERNMENT CONTRACTS AND PRIVATE FOUNDATIONS FOR TOTAL OF \$1,593,050, AND PAYMENTS FROM FEE FOR SERVICE BILLING. SERVICES INCLUDE PSYCHIATRIC ASSESSMENTS AND EVALUATIONS, HEALTH SCREENINGS, INDIVIDUAL AND GROUP PSYCHOTHERAPY, MEDICATION MANAGEMENT, COORDINATION OF PHYSICAL AND MENTAL HEALTH CARE, HEALTH AND WELLNESS EDUCATION AND SPECIALIZED SUBSTANCE ABUSE COUNSELING. SERVICES ARE PROVIDED IN ENGLISH, SPANISH AND OTHER LANGUAGES. THE CLINIC PROVIDES OVER 10,000 VISITS ANNUALLY TO OVER 500 CLIENTS. THE CLINIC IS LICENSED BY THE NEW YORK STATE OFFICE OF MENTAL HEALTH.
